Dining room seating is 48 with an additional 65 in the banquet room. Beer and wine are served.

The facility is housed in a stand alone building with a great corner location. The building is part of the sale. The exterior of the building is newly painted and restrooms have been newly updated and new carpet has been installed in the entire facility.
