

PRODUCE PACKING AND STORAGE FACILITY

THE BUSINESS

This facility has been used for a variety of produce packing throughout the years. Currently it is being operated as an onion packing plant. The current owner will guarantee onion supply should the new owner continue the onion operations. However, the facility could be modified to pack a variety of produce from apples to tomatoes. The site can both process and store produce.

THE LOCATION

The property is located in one of the most fertile growing areas of Idaho. The Idaho-Eastern Oregon onion industry is one of the largest producers of summer storage onions in the country with approximately 23% market share in the national value of production.

ASSETS INCLUDED

The sale includes all real estate and onion packing equipment. Long term training or support from the seller is negotiable. The main facility has rail and State Highway access for good transportation access. The real estate being offered is located on two separate parcels. The main parcel has 8 buildings and a house totaling 78,202 square feet on approximately eight acres. The second parcel houses a 7,500 square foot building.

THE MARKETS

The facility is in one of the most productive agriculture areas of the country. The Idaho-Eastern Oregon onion industry is one of the largest summer storage onion production regions in the country. In terms of the area planted, this region is the second largest following California. Idaho growers harvested approximately 8,800 acres of onions in 2009, up 2 percent from last year. Onion acreage planted in Idaho is estimated at 9,000 acres, also up 2 percent from 2008. The Idaho-Eastern Oregon region's market shares in the total national production of summer storage onions were 26.6% in 2004 and 20.6% in 2006. The region was ranked as the first and third largest producer of summer storage onions in the country in these two years.
